4. Presentations:

- 4.1. Childcare Report by Brandy Usick & Susan Prentice.
 - This group was put together because the GSA raised the issue of childcare on campus last year.
 - There is little statistical data available to determine the need for childcare on campus.
 - The ratio of post-secondary students who are parents of children 0-12 was applied to the number of students on campus, as well as the number of faculty and staff who are parents to children aged 0-6.
 - o There are at least 3000 students on campus with children
 - o Among Faculty at least 348 employees have children
 - 1101 staff have children
 - There are only 128 childcare spaces on campus (Fort Garry and Selkirk locations)
 - The committee looked at the Strategic Planning Framework to determine where childcare would fit in. It fits under the sections:
 - Student Experience
 - o Indigenous Achievement
 - o Outstanding employer
 - Short term recommendations: collect and analyze data staff students, enhance the current facilities, capitalize on current planning.
 - Long term recommendations: integrate family services into all student housing, include childcare into future and capital building plans, review U15 policies for best practices

• The presenters recommended to council that the UMGSA write a letter to legislature regarding childcare on campus, to try to get graduate student voices heard in consultations with the province

- 9.1. Executive Committee Report
