 - 13.1. Proposed Addition of the Student Senate Caucus to the Committee Policy: The Student Senate Caucus is a non-binding joint-committee with UMSU which facilitates collaboration among student members of Senate. UMSU Council recently formalized the Student Senate Caucus in their policies, and this proposed addition to our Committee Policy would formalize it for us. This version is recommended by the Bylaws and Policy Committee after review. Though the formatting has been adapted for the UMGSA, the wording mirrors UMSU's for consistency. The full wording of both our proposed UMGSA version, as well as the current UMSU version, are included as Appendix VI to this council meeting agenda.

MOTION: BIRT the UMGSA Council approves the addition of the Student Senate Caucus to the UMGSA Committee Policy and Procedure Manual as a new point 18 under Article V, as written.

13.2. Replacement of the Multi-Function Copier-Printer-Scanner: The Executive has investigated possible options for a replacement of our current multi-function copier. It has been used well past its intended lifespan, and it has been functioning increasingly poorly in recent months. After discussions with IST, we will be able to take advantage of the University's discount from their supplier, and we would have a 7-year service contract with the company. Based on our needs, the Taskalfa 5002i was determined to be the best option for us. We believe that this machine will be reliable and long-lasting, and will provide good value for the Association. With this new machine we will be discontinuing fax services, which are almost never used and would not be worth the approximately \$500 in additional cost. The per-page costs over the span of the associated 7-year service contract will be less than what we pay now. Particularly thanks to the University discount, we have not found better alternatives. Thanks to cost savings found over this year, as well as higher than budgeted student fee revenues, there is more than enough money remaining in this year's budget to cover the cost of this purchase.

MOTION: BIRT the UMGSA Council approves the addition of \$5700 to the 2017-18 UMGSA Budget for the purchase of the Taskalfa 5002i.

13.3. Addition of \$100 to the 2017-18 UMGSA Budget for Hospitality for Council Meetings: Due to slightly higher turnout to UMGSA Council meetings over the course of the past year, we are short by \$100 to cover food for this final Council meeting. There is more than enough money remaining in this year's budget to cover the cost of this increase.

MOTION: BIRT the UMGSA Council approves an additional \$100 in the 2017-18 UMGSA Budget for Hospitality for Council Meetings.

13.4. Addition of \$2500 to the 2017-18 UMGSA Budget for Special Project Grants:

The Special Project Grant budget line was cut mid-year when there had been almost no applications. Since that time, there have been a large number of applications, and we have exceeded the reduced budget for these grants. We are budgeting an increase of \$2500 on top of the existing \$2000 budgeted, in order to cover grants already paid out as well as some that are pending. There is more than enough money remaining in this year's budget to cover the cost of this increase.

MOTION: BIRT the UMGSA Council approves an additional \$2500 in the 2017-18 UMGSA Budget for Special Project Grants.

13.5. Proposed Clarification of Open Eligibility for Councilors and Department GSAs:

The UMGSA has received a complaint from a grad student who wished to run for an executive position on his Departmental GSA, but was excluded from running based on restrictions within the group's policies. Their policies effectively allow current executives to determine who will or will not have the opportunity to run for election. After extensive deliberations, the Bylaws and Policy Committee recommends that an additional point be added to the Council Policy to require that all grad students within a department be eligible to run as their department's UMGSA Council representative, as well as be eligible to run for their own group's executive positions. This proposal seeks to clarify and expand on the already-existing requirements for democratic procedures within the Departmental GSAs that send representatives to the UMGSA Council. The full wording of the proposed addition to the UMGSA Council Policy and Procedure Manual is included as Appendix VII to this council meeting agenda. We are excited to plan the social events for this conference happening in the Brodie Centre at Bannatyne campus, and look forward to co-hosting it with Dr. Ed Kroeger at the U of M.

UMGSA Executive Reports March 1st - 31st, 2018

President - Carl Neumann

- Required Leave of Absence During the UMGSA General Election: In accordance with UMGSA policies, as a current executive running in the UMGSA General Election I was required to take a leave of absence during the two campaigning weeks, from March 12th to 23rd. I was not permitted to hold office hours nor attend UMGSA meetings during that time.
- Collaboration Meeting with the International Centre: On March 14th, I met with the International Centre to discuss and give input for their planned academic bridging program for international students. We also discussed various other opportunities for greater collaboration.
- Meeting with the University Secretary: On March 21st, I met with the University Secretary, along with the UMSU VP Advocacy. We discussed my proposal to align Student Senator terms on the Senate with the UMGSA and UMSU Executive terms. Currently, Student Senators begin their terms on the Senate on April 1st, while Executive terms start on May 1st. This currently creates unnecessary logistical problems, including too little preparation time for newly-elected Senators. The University Secretary believes that this change will not be difficult to implement.
- **Final Planning Meeting with Student Affairs and UMSU:** After the previous two meetings in February, on March 23rd Ruth and I attended the final session of the planning meetings organized by the Student Affairs office, along with representatives from UMSU. This meeting focused on more detailed plans and opportunities for changes to the use of a few spaces within the University Centre, based on discussions at the previous meetings. Possible changes are unlikely to be implemented in the short term.

Proposed Addition of the Student Senate Caucus to the Committee Policy and Procedure Manual Along With the Current UMSU Version

Proposed UMGSA Version:

Article V: External Committees

- 18. Student Senate Caucus
 - a. Membership
 - i. The Student Senate Caucus shall be composed of:
 - a. The UMGSA Vice-President Academic, as Co-Chairperson;
 - b. The UMSU Vice-President Advocacy, as Co-Chairperson;
 - c. The UMGSA President;
 - d. The UMSU President:
 - e. All undergraduate and graduate student members of the University of Manitoba Senate, the University Discipline Committee, and all Senate Committees.

b. Mandate

- i. The mandate of the Student Senate Caucus shall be to provide an open forum for student senators to discuss the affairs of Senate and the Committees of Senate, facilitate the development of questions to be brought forward to Senate, and nominate members to the standing committees of Senate. The mandate of the Student Senate Caucus shall also be to provide a coordinated effort for advocacy efforts and student representation on campus through regular meetings, discussions, and leadership.

- iii. No action of the Student Senate Caucus is binding upon the Executives or the Council of the UMGSA, nor upon the Executives or the Board of UMSU.

Student Senate Caucus

Mandate

141. The mandate of the Student Senate Caucus shall be to provide an open forum for student senators to discuss the affairs of Senate and the Committees of Senate, facilitate the development of questions to be brought forward to Senate, and nominate members to the standing committees of Senate. The mandate of the Student Senate Caucus shall also be to provide a coordinated effort for advocacy efforts and student representation on campus through regular meetings, discussions, and leadership.

- 145. No action of the Student Senate Caucus is binding upon either the Executives or the Board of UMSU or UMGSA.

148. When appropriate, the Vice President Advocacy will present motions and/or policies of Student Senate Caucus to the University of Manitoba Senate and/or the appropriate Committee(s), or to any related UMSU Committee or The UMSU Board of Directors.

Appendix VII:

Proposed Addition to the Council Policy and Procedure Manual to Clarify Open Eligibility for Councilors and Department GSAs

Existing Point 2, a of Article IV Including the Proposed Addition of Point ii:

Article IV: Membership and Voting Rights

- 2. Councilors of the Association
 - a. Each department which offers a graduate program shall be entitled to send a representative member to Council.
 - i. The Councilor must be chosen democratically by the membership of the applicable department, on a regular term determined by the departmental membership.
 - ii. In order to have a representative on Council, all graduate student members of the department must be eligible to run for election as their UMGSA Council representative, as well as for election to their departmental graduate students' association's executive positions.

February 2nd, 13th, and 19th, 2018 March 12th, 19th, 20th, 21st, 22nd, 25th, and 28th, 2018

Nomination Period

The nomination period ran from February 5th to February 16th 2018. There were originally 11 nominations with one candidate (Ahmed Elwali) nominated for two different positions by the same group of graduate students. When he was contacted to choose on position in with the regulation, he asked the C.R.O. to first tell him the candidates for the two positions he was nominated for before he makes his choice. After the online meeting and voting by the election committee, he was mandated to choose one position on or before 9:00 am on Wednesday, February 21st, 2018 which he did through an email to the C.R.O.

The 'All-Candidates Meeting' was held on Wednesday, February 21st, 2018, at 10:00am. After the meeting, through an email to the C.R.O., one candidate decided not to run.

Candidates ran for the following positions:

- President: Carl Neumann
- Vice President Academic: Silvia Araujo
- Vice President External: Skye David Kushner, Ahmed Mamdouh Elwali
- Vice President Internal: Cody Ross
- Vice President Marketing and Events: Sakib Rahman
- Senator: Laura Forsythe, Roxanna Koohgoli, Nwaiwu Chidiebere Felix

Campaign Preparation Period:

The campaign preparation period ran from Monday, February 26th to Friday, March 9th, 2018. The candidates prepared for their campaign with one slate formed and two candidates running as independent candidates.

ACE Slate: Carl Neumann (President), Silvia Araujo (Vice President Academic), Skye Kushner (Vice President External), Cody Ross (Vice President Internal), Sakib Rahman (Vice President Marketing and Events), Laura Forsythe (Senator) and Roxanna Koogholi (Senator).

Independent candidates: Nwaiwu Felix Chidiebere (Senator) and Ahmed Mamdouh Elwali (Vice President External)

Campaign Period

Campaigning took place form 9:00 am on Monday, March 12th to 8:00 pm on Friday, March 23rd, 2018.

All candidates who currently sit on the Executive Committee were required to take a leave of absence from duties.

The 'All candidate's forum' took place on Wednesday, March 14th, 2018 from 11:30 am to 1:10 pm at the UMGSA lounge, 217 University center with the UMFM and The Manitoban covering the event.

Voting Period

The voting period began at 9:00 am on Wednesday, March 21st to 8:00 pm on Friday, March 23rd, 2018. All voting was conducted online through Tomkorp Computer Solutions Inc. All students were emailed instruction on how to vote. Just like in other elections, students got their voting instruction in the junk/spam folder but through the intervention of the University of Manitoba IST, some students got their voting instruction re-sent to their inbox folders.

A total of 742 students voted on at least one position, totaling 20.5% of graduate student population while a total of 554 students voted on all positions totaling 15.3% of the graduate student population.

Original Penalties

Due to the contravention of UMGSA Election and Referendum Policy and Procedure Manual of the University of Manitoba Graduate Students' Association that prohibits the use of campaign material not approved or banned by the C.R.O, sending of emails or campaign materials not solicited for by graduate students and violating the University of Manitoba rules, policies, regulations and procedures on use of emails obtained through the University's email-list for mass emailing, the C.R.O in agreement with the D.R.O and election committee in a meeting held on March 19, 2018 decided to penalize defaulting candidates after a long investigation. The following penalties were given:

- ➤ 5% (1 demerit) reduction in total vote cast to Ahmed Elwali for sending campaign email that were not approved by the C.R.O, sending out unsolicited campaign emails and not following University of Manitoba rules in use of email(s) obtained from University of Manitoba emailing list.
- ➤ 5% (1 demerit) reduction in total vote cast to Ahmed Elwali for campaigning with a poster that has been banned, destroyed, printing cost refunded and warned never to use again by the C.R.O

These penalties unfortunately affected the ultimate outcome of the election of only position (Vice President External).

Appeal(s):

Before voting started, Ahmed Elwali filed two (2) appeals.

- ➤ Ahmed Elwali filed an appeal against the C.R.O on March 19, 2018 and in a meeting on March 20, 2018, the elections committee dismissed the appeal for his inability to state categorically why he was filling an appeal. Hence, the election committee could not make a prima facie from the case.
- ➤ Between March 20 and 21, 2018, Ahmed Elwali wrote a mere email to the election committee chairman which he tagged "Appeal number 2" which the elections committee unanimously voted and dismissed for not following the proper procedure in filing an appeal.
- ➤ After the voting period, Elwali Ahmed submitted two (2) appeals to the elections committee. Though of one the forms were filled with complaints against the C.R.O and the other been against the penalties assigned to him by the C.R.O. On Sunday, March 25, 2018 the election committee scheduled a hearing with Ahmed Elwali and the C.R.O from 12:05 pm to 4:25 pm where Ahmed Elwali presented his case and the C.R.O defended the penalties issued to Ahmed Elwali with all the evidence gathered during the cause of his investigations. At the end of the hearing, the election committee voted and affirmed the penalties assigned to Ahmed Elwali in line with the Election and Referendum Policy and Procedure Manual of the University of Manitoba Graduate Students' Association.
- ➤ After the votes has been published, Ahmed Elwali filed another appeal seeking the repeal of the elections committee's decision and reduction/cancellation of the penalty given to him by the C.R.O. The committee voted and through its chairman (Andrew Treger) informed that him that his appeal won't be going forward as they have already ruled on that subject matter and according to the regulation, no appeal exists from the ruling of the elections committee.
- ➤ Also, after the election, Ahmed Elwali filed a complaint against the ACE slate regarding unfair publication by "The Manitoban" towards them but was dismissed by the C.R.O for not following the procedure in line with the regulation. However, the complaint was still investigated and found to be untrue.

Recommendations for future elections:

The following recommendations have been made by the members of the Elections Committee and candidates in the election regarding future elections:

- ➤ Due to the confusion in the deadline in approving campaign materials, campaign material approval should end before campaigning starts.
- ➤ Slate formation should categorically end with the nomination period.
- ➤ No candidate should be nominated for two different positions.
- ➤ Agenda should be handed over to candidates before the all candidates forum and the time assigned to them to respond to a question should be firm.
- ➤ Even social media/digital campaign is allowed, sending of emails solicited or not should be banned as students find it irritating and University of Manitoba prohibits use of emails obtained from University mailing list for mass emailing.
