1. Call to Order (5:30pm).

2. Traditional Territories Acknowledgement

13. New Business

13.1. Proposed Addition of the Student Senate Caucus to the Committee Policy: The Student Senate Caucus is a non-binding joint-committee with UMSU which facilitates collaboration among student members of Senate. UMSU Council recently formalized the Student Senate Caucus in their policies, and this proposed addition to our Committee Policy would formalize it for us. This version is recommended by the Bylaws and Policy Committee after review. Though the formatting has been adapted for the UMGSA, the wording mirrors UMSU's for consistency. The full wording of both our proposed UMGSA version, as well as the current UMSU version, are included as Appendix VI to this council meeting agenda.

MOTION: BIRT the UMGSA Council approves the addition of the Student Senate Caucus to the UMGSA Committee Policy and Procedure Manual as a new point 18 under Article V, as written.

13.2. Replacement of the Multi-Function Copier-Printer-Scanner: The Executive has investigated possible options for a replacement of our current multi-function copier. It has been used well past its intended lifespan, and it has been functioning increasingly poorly in recent months. After discussions with IST, we will be able to take advantage of the University's discount from their supplier, and we would have a 7-year service contract with the company. Based on our needs, the Taskalfa 5002i was determined to be the best option for us. We believe that this machine will be reliable and long-lasting, and will provide good value for the Association. With this new machine we will be discontinuing fax services, which are almost never used and would not be

worth the approximately \$500 in additional cost. The per-page costs over the span of the associated 7-year service contract will be less than what we pay now. Particularly thanks to the University discount, we have not found better alternatives. Thanks to cost savings found over this year, as well as higher than budgeted student fee revenues, there is more than enough money remaining in this year's budget to cover the cost of this purchase.

MOTION: BIRT the UMGSA Council approves the addition of \$5700 to the 2017-18 UMGSA Budget for the purchase of the Taskalfa 5002i.

13.3. Addition of \$100 to the 2017-18 UMGSA Budget for Hospitality for Council Meetings: Due to slightly higher turnout to UMGSA Council meetings over the course of the past year, we are short by \$100 to cover food for this final Council meeting. There is more than enough money remaining in this year's budget to cover the cost of this increase.

MOTION: BIRT the UMGSA Council approves an additional \$100 in the 2017-18 UMGSA Budget for Hospitality for Council Meetings.

13.4. Addition of \$2500 to the 2017-18 UMGSA Budget for Special Project Grants:

The Special Project Grant budget line was cut mid-year when there had been almost no applications. Since that time, there have been a large number of applications, and we have exceeded the reduced budget for these grants. We are budgeting an increase of \$2500 on top of the existing \$2000 budgeted, in order to cover grants already paid out as well as some that are pending. There is more than enough money remaining in this year's budget to cover the cost of this increase.

MOTION: BIRT the UMGSA Council approves an additional \$2500 in the 2017-18 UMGSA Budget for Special Project Grants.

13.5. Proposed Clarification of Open Eligibility for Councilors and Department GSAs:

The UMGSA has received a complaint from a grad student who wished to run for an executive position on his Departmental GSA, but was excluded from running based on restrictions within the group's policies. Their policies effectively allow current executives to determine who will or will not have the opportunity to run for election. After extensive deliberations, the Bylaws and Policy Committee recommends that an additional point be added to the Council Policy to require that all grad students within a department be eligible to run as their department's UMGSA Council representative, as well as be eligible to run for their own group's executive positions. This proposal seeks to clarify and expand on the already-existing requirements for democratic procedures within the Departmental GSAs that send representatives to the UMGSA Council. The full wording of the proposed addition to the UMGSA Council Policy and Procedure Manual is included as Appendix VII to this council meeting agenda.

MOTION: BIRT the UMGSA Council approves the addition of the new point ii to Article IV, 2, a of the UMGSA Council Policy and Procedure Manual as written.
