Other Information

Commission on Tuition Fees and Accessibility to Post-Secondary Education in Manitoba A one-person (University of Toronto professor, Ben Levin) commission has been given a mandate to review the province's policy on affordability, accessibility and on the relationship between tuition fees and student aid and accessibility to post-secondary education in Manitoba. The commissioner will outline the recommendations in a report to the Manitoba Advanced Education and Literacy Minister by March 2009. Dr. Levin kicked the commission off with 2 afternoons of open consultation sessions with stakeholders. I attended on behalf of graduate students on September 16, and brought grad student issues up with the commission that seems to be almost exclusively focusing on undergraduate accessibility and student aid. I stressed the need for both increased funding for graduate students and low (or no) tuition and user fees, and the impact of differential fees on international students. Although there are no public hearings being scheduled, it is possible to make submissions to the commission online or by snail mail, see http://www.postsecondarycommission.mb.ca/ for more details.

Board of Governors

The University of Manitoba Board of Governors (BoG) met at the Bannatyne Campus on September 16. The President gave a lengthy and informative presentation on his first 100 days on the job, and outlined his vision of what the Board's responsibilities are to him (as

"CEO") and vice versa. As well, the BoG approved a new Student Discipline Bylaw for the University of Manitoba. While the bylaw is not perfect, it has some needed improvement and changes, such as adding the GSA President as an *ex-officio* University Discipline Committee member. A number of concerns were flagged and raised by UMSU and the GSA, many of which were considered and even incorporated by the committee into the new bylaw.

Rally and Campaign for Aboriginal Student Access and Funding
I attended a rally and march on September 17 organized by the Southern Chiefs
Organization, University of Winnipeg Aboriginal Student Council, University of
Manitoba Aboriginal Students' Association and the Canadian Federation of Students. The
event began with a short rally and march from the Indian and Northern Affairs Building
to the Legislature where Aboriginal student leaders and chiefs spoke. The campaign is
part of a broader Action for Aboriginal Access initiative, which is demanding the federal
government lift the 2% cap on funding increases for the Post Secondary Student Support
Program, the federal government and province provide more grants for Aboriginal
students and that they sign onto the United Nations Declaration on the Rights of
Indigenous Peoples.

Other Information

While the exciting but extremely busy times of September have ended, the GSA Executive has remained active organizing the office, attending meetings on and off campus, and planning initiatives and events for the remainder of the year. We strongly encourage graduate students to come by the office and chat or hang out when you get the chance. Also, we are always in need of volunteers for committees and helping with events so if you or other students you know are interested, please give us a call, shoot us an email or pop by the office!

GSA Endowment Fund

Following the signing of the autonomy agreement with UMSU in April 2007, the GSA received 14% of the UMSU Endowment Fund that Graduate Students had been paying into up until that point (U of M was about 14% grad students at the time, this was equivalent to approximately \$500,000 of the Endowment Fund). The money was subsequently put into a high-rate savings account at the Assiniboine Credit Union, with the intention of eventually investing the money and using the return to fund GSA Travel Grants and/or other scholarships and bursaries for Graduate Students. During 2007-2008 the previous GSA Executive met with Lawyers and Financial advisors a few times with the intention of establishing an Endowment Fund Board to oversee the investment of the money. This was not completed and has been left to the current Executive to deal with. The Endowment Fund money has remained in a high-rate savings account at the credit union until present, which has been a smart move in hindsight (given the volatility of the commercial banks and markets), as it has gained thousands of dollars in interest. Currently we are in the process of transferring the Fund to a modest 1-year redeemable GIC at the credit union for the time being will it earn approximately 1% more in interest. We have been meeting with the Assiniboine Credit Union and their investment partners regarding long-term investment of the funds in a financially and socially responsible manner. Preservation of the principal and ethical investment will be a priority for the Fund, even if the return from the investment is modest in the first few years. We hope to have the plan for the Endowment Fund money in place by early 2009 for the GSA Annual General Meeting.
