While the exciting but extremely busy times of September have ended, the GSA Executive has remained active organizing the office, attending meetings on and off campus, and planning initiatives and events for the remainder of the year. We strongly encourage graduate students to come by the office and chat or hang out when you get the chance. Also, we are always in need of volunteers for committees and helping with events so if you or other students you know are interested please give us a call, shoot us an email or pop by the office!

#### **GSA Endowment Fund**

Following the signing of the Autonomy agreement with UMSU in April 2007, the GSA received 14% of the UMSU Endowment Fund that Graduate Students had been paying into up until that point (U of M was about 14% grad students at the time, this was equivalent to approximately \$500,000 of the Endowment Fund). The money was subsequently put into a high-rate savings account at the Assiniboine Credit Union, with the intention of eventually investing the money and using the return to fund GSA Travel Grants and/or other scholarships and bursaries for Graduate Students. During 2008-2009 the previous GSA Executive transferred the Fund to a GIC at the Assiniboine Credit Union for a year. This GIC became mature on Oct 22, 2009. Currently we are in the process of transferring the Fund to a modest GIC at the credit union for better interest. We are going to have a meeting with the Assiniboine Credit Union and their investment partners regarding long-term investment of the funds in a financially and socially responsible manner. Preservation of the principal and ethical investment will be a priority for the Fund, even if the return from the investment is modest in the first few years. We hope to have the plan for the Endowment Fund money in place by next council meeting.

# Canadian Federation of Students Annual General Meeting

GSA Executive committee members, Trish Kelly, Mohamed Moustafa, Andy Bonar, Aaron Glenn, and Parvez Vora from HSGSA will be representing the GSA and attending the Canadian Federation of Students Annual General Meeting from November 25 to November 28 in Ottawa.

#### **President resignation:**

On Oct 8, President Sabouni announced his resignation of Presidency, effective October 31, 2009. Please see the attached letter. According to the GSA constitution: Article IV Election, item j, "Any position vacated on or after October 1st shall be filled for the remainder of the year through appointment.

i. The Executive shall make a recommendation to be voted on by council."

Please note that there is a typographical error in the constitution on the website: Article IV 1i) which reads:

#### International College of Manitoba (ICM)

In the Board meeting, President Barnard report that, there has been agreement between university administrator and Navitas that there would be a comprehensive review of ICM at the end of the fifth year of its operation at the University of Manitoba - during the autumn term of 2013/14. This review would be overseen by the Senate Committee on Academic Reviews and would be modeled on the academic program reviews approved by Senate.

# University's estimates of operating and capital requirements for 2010/2011

Based on president report in board meeting, a base grant increase of 12.9% or \$36.4M is required to sustain the 2009/10 programming levels the same as this year. University administrator starts looking for different possibilities to compensate this budget.

#### Student enrolment for 2009/10

Fortunately, the student enrolment at the University of Manitoba for this year increases for 4.3%, in both undergraduate and graduate student enrolment.

# **H1Nl Flu vaccination**

The Winnipeg Regional Health Authority is offering free H1N1 influenza immunization clinics for students, faculty and staff of the University of Manitoba. No appointment is necessary. It is taking place on the Fort Garry Campus. The clinic is taking place in Helen Glass Atrium from October 26 to October 28, and in Room 210 University Centre from October 29 until December 4.

#### **Election of a Chancellor**

The Chancellor is the titular head of the University and confers all degrees. The term of office of the chancellor is three years, commencing June 1 of the year in which he is elected. Dr. William Norrie's three-year term as Chancellor commenced June 1, 2001, and was re-elected for additional three-year terms effective June 1, 2004 and June 1, 2007 The Call for Nominations for Chancellor will be soon.
