The Finance Committee met on November 17 and approved 15 Conference Travel Grant applications totalling \$4275. The total amount awarded to students to date this year is \$40940.91, of a budgeted \$65000 for this fiscal year.

We also discussed and approved 31 Department Grant applications for the fall disbursement to be recommended to Council for approval.

BIRT - Council approves the 31 Department Grant applications as presented.

One Special Project Grant and two donations were submitted to the committee. The special project grant is for funding for the Political Studies Students' Conference, to be held February 3-5, 2010 at the University of Manitoba. The GSA has provided funding for the conference in the past. The Finance Committee recommended this application to Council.

One donation was to the Art of Living Student Club, for \$2160. This amount exceeds the amount the GSA allows for donations. The GSA typically does not fund student interest groups, as our budget does not allow for the distribution of funds to all interested groups.

A second donation for \$250.00 for Project Fly Home, a speaking event by Abousfian Abdelrazik, a Canadian citizen exiled to Sudan for 6 years. The event was co-hosted by Peace Alliance Winnipeg and CanPalNet, and was held on October 17th, 2009. The Finance Committee needed more information on this event before we could approve funding.

On Monday, Nov. 2, Meaghan Labine (VP Health Sciences) and Peter Nawrot (VP Academic) brought forth concerns stemming from the Oct. 28 Council meeting to the members of the GSA Executive. At the center of these concerns are the votes resulting in Andy Bonar as the new President and Aaron Glenn as the new Executive-at-Large. Andy Bonar immediately turned the situation over to the IDR committee as per Bylaw X.1.a. and b.:

1. Committee Mandate

- a. To address all matters requiring ethical consideration within the Association.
- b. To review and provide Council with direction on any material or issue Council calls into question regarding conduct or policy.

From Nov. 2 to Nov. 9, several documents were forwarded to the IDR committee (from both the assenting and dissenting sides) and we met from 16:30 to 19:00 on Nov. 12. It is important to note that this committee operated under consensus rules, which means all members must agree on our ruling before it is presented (i.e. no voting).

The allegations made were as follows:

- 1. That dismissing the proxy votes collected by the VP Health Sciences was in violation of the GSA constitution (Article II.5) and bylaws (Bylaw IV.6).
- 2. That a "2/3 majority vote of Council" (Article IV.1.k) suggests a 2/3 majority of all registered members of the GSA Council rather than the present and voting members (or voting by written proxy) of the GSA Council.

About the Constitution Paradox:

After reading the AGM minutes from Jan. 2008, it is clear that Article IV.1.i should read "Any position vacated prior to October 1st will be filled by a by-election..." There was simply a transmission error in going from the AGM minutes to the Constitution.

IDR Committee Findings:

1. Preface:

The vote that took place to determine whether or not to include the proxy votes in the election of the Executive members also should not have happened. Council does not have the ability to suspend the Constitution or Bylaws by disallowing the proxy votes. Rather, their validity is determined by the chair (Executive-at-Large) prior to the Council meeting.

Ruling:

We find the proxy votes to be invalid since we are not convinced that they were presented to the chair prior to the Council meeting. The Constitution states that:

"The chair should receive written notice of any proxy prior to the Council meeting. For departments not situated on the Fort Garry Campus, a written proxy vote will be accepted."

We interpret "prior to the Council meeting" to mean before the call to order, which typically signifies the beginning of any meeting. Rather than being presented at this time, the proxy votes surfaced too late to be used. The main purpose of presenting the proxy votes before the meeting is so that they may be checked to see that they are in good standing (dated, signed, etc.) and also cross-referenced with the list of representatives from the Health Sciences departments. Bylaw IV.6 says that this list is on file at the "...Offices of the Graduate Students' Association". Our interpretation is that this list ought to be on file at both GSA offices and must be examined by a scrutineer (the Office Manager or chair for example) to ensure those listed are registered students from the correct departments. Without a process like this, the list is senseless. At any rate, such a list was not presented before the call to order.

2. Preface:

The concern here is the interpretation of "2/3 majority vote of Council" and by consequence "simple majority vote of Council". The dissenting side argues that "of Council" refers to all registered members of the GSA Council; there are 51 at present. Thus, any 2/3 majority vote would require 34 votes in the affirmative and any simple majority vote would require 26 votes in the affirmative.

Ruling:

It is not immediately obvious what "of Council" refers to in Article III.1.k; however, after discussing the Constitution at length, we decided that the interpretation is "of present and voting members (or voting by written proxy) of Council" rather than "of all Council" or "of all Councillors". We do not believe that the GSA has been acting contrary to the Constitution, but we do believe there is a clarity issue. The words "of Council" could take on either meaning, depending on the context. See the two examples below:

Example 1:

Article X.3

"The enactment, amendment or repeal of any Bylaw shall require a two-thirds (2/3) majority vote of the Council or General Meeting."

In this case (and in all but one – see below), the interpretation here is that "of the Council" and "of the General Meeting" mean 2/3 of present and voting members (or voting by written proxy). To suggest that the meaning is total membership, then the General Meetings would require 1192 affirmative votes for a simple majority vote while 1589 affirmative votes would be required for a 2/3 majority vote – well outside the realm of plausibility.

Example 2:

Article VIII.3

"The quorum of the Council meetings shall be one half (1/2) of the Council"

When dealing with a quorum requirement, "of the Council" refers to total membership. Saying that quorum is half (1/2) of the present and voting members (or voting by written proxy) would be nonsense.

Note: If in both examples, "of Council" referred to total membership, then quorum would be equivalent to the minimum number of affirmative votes to pass even the simplest of motions, such as adjournment. Needless to say, this would be an odd interpretation.

Since we believe the term "of Council" (or "of the Council") to be ambiguous, we also note that it suffices to refer to past practice of the GSA Council meetings. In the past, quorum has been 1/2 of the registered membership of the GSA, while "of Council" for a 2/3 majority vote or a simple majority vote refers to the present and voting members (or voting by written proxy).

Summary:

In conclusion, we find both allegations made by the dissenting side to be without sufficient grounds. Thus, the ratifications of both Andy Bonar and Aaron Glenn stand. Now that we have given our report, we stress that this issue be laid to rest and that the GSA carry on with business as usual.

We have several recommendations to make to the Bylaws Committee regarding the Bylaws and the Constitution. In the meantime, we urge the VP Health Sciences and the Executive-At-Large to convene to minimize problems with proxy voting in the future.

Committee Update:

This committee was struck to evaluate the operations of the Health Sciences Caucus due to concerns raised by the Executive. Over the last four years the Health Sciences disbursement has grown from \$5,000 to \$10,000 to \$16,000. At the May meeting of the GSA Executive the Vice-President Health Sciences requested that the disbursement be increased to \$25,000. While the majority of this growth might seem alarming, it should be known that the GSA's membership revenue has grown (due to autonomy) over the last three years from \$130,000 to \$260,000 to the approximate \$290,000 it is at today. Student fees, however, remain unchanged. Moreover, the responsibility of the GSA, with autonomy, has grown. It is thus not unreasonable that the Health Sciences budget was increased in the past for purely expansive reasons, however, the Executive had concerns over the reasoning behind the current increase—was the GSA not doing enough to support the Health Sciences students?

At the first meeting of the Committee a plan was drafted to address the operations of the Health Sciences Caucus, its funding, as well as the representation of its members. The plan was to hold four meetings. The committee also requested that the Health Sciences Caucus turn over all financial documents for an audit.

The second meeting was to address the GSA Office on the Bannatyne Campus, which was not functional at that time. The committee requested that the GSA Executive purchase a computer, printer, shelving units, phone, office supplies, fridge, and a couch—essentially, an office. Everything but the couch has been purchased and the GSA Office at the Health Sciences Campus is fully operational, with the Vice-President (Health Sciences) and her HSGSA representatives holding office hours in it every day of the week. It should not be underscored what a great thing this is for the GSA.

The third meeting was to address the HSC finances. When examined, it was realized that there were some issues with the financial records of the Health Sciences Caucus. Working off of the Health Sciences check stubs, it was observed that the total expenses for 2008-2009 were 17,193.88—essentially, right on budget. However, in the first month of the 2009-2010 fiscal year, the Health Sciences expenses, again working from check stubs, were a reported \$6,452.95—just under half their budget for the 2009-2010 fiscal year. It is expected that the Health Sciences Caucus will run over budget considerably this year (~\$26,582.87 over budget), and while this is negligibly offset by an additional \$4,200 paid to the Health Sciences for honoraria, their actual honoraria costs are \$11,600. The Health Sciences Caucus has claimed additional income to the monies given to them by the GSA, but no records were turned over to the committee. It is anticipated that these records will clear up some of the discrepancy. The committee was unable to come to any decision regarding the finances.

Given the developments of the past two months, it no longer makes sense to have Executive members from the Health Sciences or GSA serving on the committee. The remaining meetings were to address the representation of Health Sciences departments on GSA Council, as well as the Constitution and Bylaws. It is important that the financial issues, as well as the representation issues are solved reasonably and fairly.

At the last GSA Executive meeting, it was suggested that the Executive members of the Committee from the GSA and HSC remove themselves from the committee (with the exception of the Executive-at-Large, who will stay on as Chair) in hopes of facilitating a quicker resolution to these matters

Research Funding Attacked by the Canadian Federation of Students:

In an "Education Action Plan" lobbied to the Canadian government this past month, the Canadian Federation of Students, to whom graduate students at the University of Manitoba provide approximately \$60,000/year, requested that the government begin reducing the amount of money that graduate students are able to take in as research funding, through the taxation of research grants, scholarships, stipends and fellowships. Please see attachment A, which is an article that has been submitted for publication in the Gradzette. This issue will be brought up at the CFS National AGM in Ottawa next week. There are thirteen other schools that have expressed dissatisfaction with the actions of the CFS. The attached article was drafted in concert with the President of the McGill Post-Graduate Students' Society, Daniel Simone.

Legal Issues:

The final hurdle to registering the Association as "The University of Manitoba Graduate Students' Association" has been cleared. COPSE (the Council on Post-Secondary Education), which represents an arms-length board of the provincial government, has green lit the use of "University" in our name. Last month, the Board of Governors approved "University of Manitoba", so, we are now, finally, The University of Manitoba Graduate Students' Association in name as well as practice.

We will now be working to finalize the agreement with the University of Manitoba concerning the recognition of our autonomy. President Barnard has informed us that, in principle, the University is in favour of this agreement. We anticipate total autonomy very soon.

Financial Investment:

The Executive will be meeting with our Credit Union soon to reinvest our funds in a GIC. We were looking to be more aggressive in an attempt to grow our capital, but investment in the market at this point does not seem to be the best strategy. A GIC will allow us to review this matter again next year, without any loss to our capital.

Graduate Student Bursaries:

Subsequent to the autonomy agreement between UMSU and GSA, graduate students are no longer included in UMSU bursaries. Unfortunately, there was no plan in place on the GSA's part to recompense graduate students affected by this consequence of the agreement. We are pursuing options to create a bursary fund for graduate students, and are hoping that this can be done without any changes in fees paid by members.

GSA/HSGSA:

Over the last month I have been working a great deal to represent the issues of the Health Sciences graduate students within the GSA Executive Committee and Council. Many issues have come up regarding the relationship between the GSA and HSGSA, and we are working towards resolving them so that we can build a productive relationship.

Health Sciences Advocacy:

Involvement with the Faculty of Medicine

Recently, the HSGSA has been looking into how to strengthen the relationship between the Faculty of Medicine and graduate students within the Faculty of Medicine. Traditionally, graduate students have had little interaction with medical students and with Faculty of Medicine proceedings. To give graduate students a voice on campus, I have approached the Faculty of Medicine to include graduate students on more Faculty of Medicine committees and on the Faculty of Medicine Council. Currently we have filled 5 spots are reserved for graduate students on the Faculty of Medicine Council. In addition to that, we now have representation on the Faculty of Medicine Education and Accreditation sub-committees.

Shuttle Bus Issue

Currently the HSGSA is working with UMSU to lobby the university to find a workable solution to the cessation of the free campus shuttle bus. The decision to cancel the free shuttle bus service was done so during the summer, in response to a deficit in the budget. Students so far have been very disappointed with the Winnipeg Transit alternative, which although it runs more regularly, is frequently full during peak hours. To address this issue, a petition is being sent around for students, faculty and staff to sign.

Professionalism Document

To address professional behaviour of students, faculty and staff within the Faculty of Medicine, a document was drafted by the Dean of Professionalism on the issue. I have added a paragraph

which addresses graduate student professionalism; however a companion document must be drafted to address this topic in more detail.

Student Relations Committee

This committee is chaired by the VP-Student Affairs for the University, and addresses issues which are of importance to both students and the university administration. The purpose is committee is to get the student perspective and make recommendations to various other committees on these issues. Most pressing at the moment are the ROSE and OARS projects initiated by the university.

"A university wide review of academic and administrative support services designed to reduce costs and enhances services to the university community." The review is being conducted by an independent review company through contract, and may take effect by the end of the 2010 winter semester. This project will reduce the amount of service and support staff on campus, and may in effect reduce the amount of student service providers.

"The project is intended to indentify strategies to improve and reduce barriers to the effective use of academic resources in order to move the university forward on the academic front. The true implications of this project on students is not yet known, however we are working with UMSU to stay on top of any changes/decisions made within the committee.



"Canadian Federation of Students Proposes to Cut Graduate Student Funding"

On October 19th, 2009, The Canadian Federation of Students (CFS) released a plan to drastically and unnecessarily cut the amount of money available to graduate students. In their "Education Action Plan", which was lobbied to the Federal Government this past month, the CFS recommends that the tax-exempt status on fellowships and scholarships be removed. Moreover, the CFS recommends that all education related tax credits and savings be eliminated. If the CFS has its way, all prizes, scholarships, fellowships or bursaries will be taxable, and tuition, academic fees, text book costs and other expenses covered by the Income Tax Act will no longer be eligible for tax credits.

Presently, graduate student recipients of fellowships enjoy tax-exempt status on fellowship income. This means that the entire value of federal, provincial, and University of Manitoba fellowships (SSHRC/NSERC/CIHR, MGS, UMGF, a fellowship or non-salaried research assistantship, The GSA Awards, etc.) goes to the graduate student. All graduate students are eligible to receive tax credits for their tuition, text books, and other student related expenses (like the graduate school application fee for the university you attend, the cost of binding your thesis, library fees, etc.), which helps to offset the expense of pursuing underfunded graduate education.

The loss of tax-exempt status could cost a graduate student up to \$6,000 in additional federal tax per year.

The CFS recommends that the savings realized from this change (roughly \$38M from the taxation of scholarships and fellowships) help fund a \$1.5 billion reworking of the Canadian Student Loans program. The CFS, through its student fee funded "Grants not Loans" campaign, seeks to replace student loans with up-front education grants. Any such program, even if funded to the \$1.5 billion level recommended by the CFS, would clearly exclude graduate students receiving research grants from receiving education grant funding. Not only would award-holders not see the loss in research funding from the recommended cut made up elsewhere, but the prioritization of education grants over research grants would have negative implications for many graduate degree programs where research stipends are involved.

In the United States of America, where such taxation exists, because it is unreasonable to assume that students will be able to pay at tax time the thousands of dollars that this taxation will cost a given student, the student is taxed up front on the grant. The grant's real value to the student is therefore lessened by the taxation (while the claimed total value of grants given by the donor—tax free—or government agency or university, is represented as the total amount given and *not* what the student actually takes home).

Although there are some good recommendations in the Action Plan, including a recommendation to increase the number of CGS fellowships and increased funding to aboriginal post-secondary education, the recommendation to eliminate the tax-exempt status of scholarship and fellowship income would have adverse effects on hundreds of University of Manitoba graduate students — all fellowship holders, federal, provincial, or local, as well as recipients of non-salaried research assistant stipends would be required to pay taxes on their funding.

To even propose such an option to the federal government on behalf of graduate students is unconscionable, as it is entirely possible that the government use this document as support from students in order to jettison the tax-exempt status for scholarships and fellowships—we need look no further than the recent imposition of a taxable status on the fellowships and stipends of post-doctoral researchers.

The University of Manitoba Graduate Students' Association (GSA), as a member of the CFS, should have had a say in the adoption of the Education Action Plan. The Plan, however, was not a subject for discussion at the last semi-annual general meeting of the CFS (May 2009). The first that the GSA was aware that the CFS National Executive was lobbying for changes that would cost graduate students thousands of dollars was through correspondence with McGill Post-Graduate Students' Society President Daniel Simeone. The CFS Executive made no attempt to inform the GSA of its intention of lobbying against the interests of GSA members, all of whom paid their fees in full to the Canadian Federation of Students this past year. It was not until after the document had been lobbied to government that the CFS National Executive provided the GSA with the Plan.

The GSA has been a member of the CFS since 2001, and pays more than \$41 000 in annual fees, with additional contracts and fees bringing that number up near \$60,000.
