6. Other Business

Motion regarding fee increases to graduate students at U of M.

Whereas the University of Manitoba central administration and Faculty of Graduate Studies are proposing massive graduate continuing fee increases to the Council on Post-Secondary Education.

Whereas the proposal would see continuing fees more than triple over the next three years using the following model:

Current continuing fees: \$633/year

Proposed Sept 2010 fees: \$1000 (increased by \$367/year) Proposed Sept 2011 fees: \$1500 (increased by \$867/year) Proposed Sept 2012 fees: \$2000 (increased by \$1367/year)

Whereas the Faculty of Graduate Studies only made the GSA aware of such a proposal on April 22nd, 2010 and the University is reported to be submitting its

proposals for increased tuition to the Council on Post-Secondary Education by the end of April, meaning there is no possibility of a thorough consultation.

Whereas the Graduate Students' Association has consistently opposed massive tuition/continuing fee increases in the past, including the complete rejection of proposals to radically increase graduate student tuition in 2007 – a position which was supported by the Faculty of Graduate Studies Council.

Motion

BIRT the GSA reconfirms its opposition to increases in continuing fees, ancillary fees, international differential fees or tuition.

BIFRT the Executive be directed to send letters to the Dean of Graduate Studies, the President of the U of M, the Minister of Advanced Education and the Secretary of the Council of Post-Secondary Education stating the opposition of graduate students to the proposed increases to continuing fees, and any other increases to continuing fees, ancillary fees, international differential fees and tuition.

BIFRT that the Executive be directed to establish a campaign against the proposed increase in continuing fees and work with other student groups, faculty councils, UMSU and other campus and community allies in opposition to the massive tuition increases being proposed at the University of Manitoba. Labine/Gonsalves

ROSE AND OARS

While the majority of the ideas that had come out of the optimization committees have not had a foreseeable negative impact on graduate students, there is one that indirectly affects many of our members. A proposal is before the Senate Committee on Instruction and Evaluation to change all 6-credit hour courses into 3-credit hour courses. In special cases, exemptions would be made for courses that are deemed to pedagogically require the term-spanning model. While this would mainly impact undergraduate courses, the proposal presents an increase to the workload of grader/markers and teaching assistants as well as a potential reduction in paid hours. The GSA is working closely with CUPE on this issue.

THE UNIVERSITY BUDGET

The Budget Process is underway, and while I cannot talk specifically about the numbers, it does appear that faculties across the board will be working with baseline budget cuts. This means that faculties will need to find ways to come up with more money in order to continue operating as they normally operate (or cut items from their baseline budgets).

The Faculty of Graduate Studies has, once again, proposed an increase to the Continuing Fees. However, this is not directly related to the budget cuts—FGS proposes this every year to the incoming GSA Executive. The incoming Executive should have no problem dealing with this issue, should they wish to fight it, as the past three Executives were all able to deny increases to the Continuing Fees.

Meeting with the Minister of Advanced Education

To address the proposed drastic increases in tuition for professional programs at the UofM, myself and members of UMSU met with the Minister of Advanced Education (Diane McGiffard) to discuss the impact that these increases would have on students and enrolment.

Meeting with the Dean of Graduate Studies

This meeting was called to address the potential increase to graduate continuing fees for Sept 2010. It was indicated that central administration is pushing heavily to get the proposal sent to, and approved by COPSE (committee on post-secondary education). The dean assured me that 100% of the increases would be going back to students in the form of bursaries and scholarships. Due to the obvious problems associated with this proposal, upon request, the Dean agreed to allow the GSA to create a graduate student committee to work with the FGS to better develop the scholarship program. To date, two town-hall meetings are scheduled for May 4th, which will allow students the opportunity to ask questions and give feedback to FGS on the new proposal before being implemented. Tuesday, May 4th: 12-1pm, Bannatyne Campus, Theatre D Basic Medical Sciences Bldg

Meeting with the Premier

This meeting was intended to address the broader concerns facing post-secondary institutions in the coming year. Due to the meeting being very short, only two primary concerns were raised with the Premier; 1) The affect that increased fees will have on enrolment, and the negative impact it will have on students in the coming year. 2) International student fees and allowing international students to automatically receive Manitoba health insurance for free while attending university.

ROSE & OARS Town Hall meeting

In order to get a little more insight into the process of ROSE and OARS that is taking place at the university, I attended the town hall meeting. Over two hundred were in attendance; however there were no other GSA representatives. The President was very vague about the process and how it will impact the university and students. The issue of student fees was addressed in addition to job security for administrative staff and service personnel, and UMFA voiced that they were not in support of raising fees, nor cutting jobs.

HSGSA AGM

During our AGM we had 15 HSC students in attendance aside from HSGSA executive members. We approved changes to the HSGSA by-laws and constitution, and provided an overall summary of the work done by the HSGSA over the past year.

HSGSA Spring it Up

Following the AGM, we had our annual Spring it Up social event in which over 90 students attended. So far this has been our most successful social we have had all year. Activities included a relay race, trivia and door prizes.

At the University of Manitoba there is an issue with graduate students, supervisors and graduate committees not being aware of their rights and responsibilities as it relates to mentoring graduate students. To ensure a greater level of consistency throughout the graduate program within the Faculty of Medicine, we have drafted the Graduate Student Memorandum of Understanding which outlines the basic parameters of what is expected of all graduate students, their supervisors and their committees while enrolled in the program. By understanding what is expected, it will be easier for graduate students to know their rights, and have a platform from which to build. Currently the document is being revised by the various graduate departments within the Faculty of Medicine, and we hope to have the document completed and in use for September 2010.

GSA Awards and Teaching Award Nominations

The GSA Awards committee will be meeting with in the next week weeks to deliberate the award applications. Council will need to extend the term of the current committee membership into the month of May 2010. Ms. Karen Jensen, Ph.D., Associate Dean, Faculty of Graduate Studies and Mr. Shahab Shokrzadeh from the Department of Engineering will be added as members of the GSA Awards Committee, to further diversify the committee membership.

Meeting with the Premier and Minister of Post- Secondary Education

This was an important meeting because it allowed for student representatives to speak directly to the Premier about issues that matter to students. Graduate student grants and the need for funding was discussed along with the proposed fee increases for graduate students. As of this date, the government has not received any funding increase proposals from the University of Manitoba. The Premier committed to not allow increases that exceed current government policy on the one hand but on the other hand he stated, along with the Minister of Post Secondary Education, that each case will be reviewed on its own individual merit. The Premier also stated that COPSE will be given an additional mandate of exploring and regulating ancillary fee increase which have been used in past to counterbalance and subsidize the tuition increase.

The Premier was made aware of the following regarding Graduate Student continuing fees and expressed a concern that these proposed fees are an increase of 58% within the first year. Within 3 years the proposed increased would total 216% in continuing fees alone.

Current continuing fees: \$633/year

Proposed Sept 2010 fees: \$1000 (increased by \$367/year) - 58% increase Proposed Sept 2011 fees: \$1500 (increased by \$867/year) - 137% increase Proposed Sept 2012 fees: \$2000 (increased by \$1367/year) - 216 % increase

Basic insured health services for international students was also discussed and will require further consultation and meeting with the Provincial Minister of Health.

The Premier is amicable to working with student groups so that students graduate from their programs in a timely way and choose Manitoba as their home and place of employment. The Premier expressed that by implementing a summer work experience program related to studies whereby students can earn a university credit and money. Employers would receive government incentives to participate in such a program.

Information on Proposed Tuition Increase Town Hall Meeting (Asper School of Business)

Dean Feltham of the Asper School of Business conducted several student consultation town hall meeting regarding the proposed tuition increases within his department and faculty. To regain and maintain the competitiveness of the Asper School of Business the Dean is proposing a tuition increase of \$15,000 for the Master's of Business and Administration (MBA) program, phased at \$5,000 per year commencing in the fall of 2010.

Many graduate students are upset and unsettled by the timing of this announcement (during exam period) and the rate of increase; 26% and within a 3 year period MBA student will have seen an increase of 76%.

Students did not feel the Town Hall Meeting was a consultation of students, but rather an information session. Students also challenged the Dean on holding a student referendum if he truly wanted to know what students wanted from their school. International students expressed concern of being able to afford such increases because many rely on their communities for support to attend school and increases are especially difficult in having to convert from indigenous currencies to the Canadian Dollar.

Summary of Meetings and Activity

December 8, 2009

This was the first meeting for a number of committee members and there was a new committee chair. We reviewed what had been accomplished by the previous committee, reviewed the original mandate and planned a course of action.

January 13, 2010

The committee came up with the following recommendations regarding the GSA-HSGSA relationship:

- 1. Stipulate that 30% of all Health Sciences graduate student fees be allocated to the HSGSA operating fund.
- 2. That a \$9000.00 general HSGSA honorarium line be added to the GSA budget.
- 3. Change wording on HSGSA budget presentation requirements so that the budget presented to GSA Council in May and November every year.
- 4. Include all HSGSA finances in the annual GSA audit.
- 5. Add non-executive members to the GSA and HSGSA IDR committees.

April 7, 2010

Decided on a plan of action to implement the recommendations. It was decided to put forward a motion to GSA Council to amend current GSA Bylaw IV (Health Sciences Caucus Bylaw). Some additional amendments to the bylaw were discussed at the April 7th meeting. Between the April 7th meeting and April 20th the committee drafted, discussed, and the amended the bylaw via email.

The present and amended bylaws are appended to this report.

IV. HEALTH SCIECNES CAUCUS BYLAW

- 1. The departments at the Health Sciences Campus, including graduate programmes in Dentistry, Medicine, and Medical Rehabilitation, are constituted into a body which shall be known as the "Health Sciences Caucus" of the Graduate Students' Association.
- 2. The Caucus shall be comprised of such membership as they should determine from time to time as being necessary for the functioning of the Caucus.
- 3. The Caucus shall elect a graduate student as President who will act as their representative to the Graduate Students' Association, and (until the 2004 GSA General Election) as Vice-President (Health Sciences Campus) of the Association.
- 4. Caucus shall have authority for dispersal of departmental allocation funds for all Health Sciences Departments, subject to the provisions of the Bylaws of the Health Sciences Caucus.
- 5. The Caucus shall receive a separate disbursement for the day-to-day operations of the Caucus to be allocated in an annual budget:
 - a. The budget shall contain allocation monies to ensure:
 - i. the continued operation of the GSA Health Sciences Campus Office:
 - ii. funding of elections for positions as specified by the Bylaws of the Health Sciences Caucus;
 - iii. costs of materials related to the effective representation of graduate students on committees on the Health Sciences Campus;
 - iv. costs of events, social or otherwise, hosted by the Health Sciences Caucus;
 - v. any other items as determined by the Health Sciences
 Caucus to be included in the budget passed by that Caucus.
 - b. Notwithstanding Bylaw IX (5)a, funding initiatives involving both the GSA and the Health Sciences Caucus may be considered at the discretion of the GSA and its Health Sciences Caucus.
 - c. The budget for the Health Sciences Campus will be set at the beginning of each fiscal year and a copy forwarded by the Vice-President (HSC) to the Executive Committee of the GSA as a report for information.

- 6. The representative of the Caucus shall be entitled to cast the written proxy votes, or in person votes, equivalent to the total number of departmental representatives from the Health Sciences departments as listed at the Offices of the Graduate Students' Association.
- 7. The first instance, concerns of individual departments at the Health Science Campus regarding the operation of the Caucus shall be referred back to the Caucus for examination. The Graduate Students' Association reserves the right to examine any serious concerns raised by Caucus members as to the utilization and disbursement of funds allocated to the Caucus.

HEALTH SCIENCES BYLAW

- 1. Members of the Graduate Students' Association (GSA) within the departments at the Health Sciences Campuses, or members within other departments who are primarily located on Health Sciences Campuses, shall be constituted into a body known as the "Health Sciences Graduate Students' Association" (HSGSA).
- 2. The HSGSA shall be entitled to draw from the GSA annual budget a sum of \$9,000 or a value equal to the honorarium set for the GSA President, whichever is greater, to use for the honoraria of HSGSA Executive Members.
 - a) The per-annum salary amounts for each HSGSA Executive Member shall be set by the HSGSA as specified in the Constitution of the HSGSA.
 - b) No Executive Member of the GSA currently receiving a GSA honorarium shall be allowed to draw remuneration from these monies.
 - c) Amounts shall be paid by the GSA in 12 equal monthly installments for all HSGSA Executive Members who are paid on a per-annum basis.
 - d) Payment of honoraria is subject to payment of CPP and EI to the Canada Revenue Agency (CRA) in accordance with CRA regulations. T4 statements will be issued by the GSA to each HSGSA Executive Member in accordance with CRA regulations.
- 3. The HSGSA shall have authority for approval of disbursal of departmental allocation funds for all Health Sciences Departments, subject to the provisions of the Bylaws of the HSGSA.
- 4. The HSGSA shall receive a separate disbursement for day-to-day operations equal to 30% of all GSA student fees paid by members of the HSGSA
 - a) Additional funding initiatives involving both the GSA and the HSGSA may be considered at the discretion of the GSA and the HSGSA.
 - b) The budget for the HSGSA shall be set by the HSGSA and the Vice-President (Health Sciences) shall present the budget to the Graduate Students' Association Council as a report of information in May and November.
 - c) The finances of the HSGSA shall be included in any financial audit performed on the GSA.
- 5. Departmental representatives of the HSGSA shall be entitled to cast proxy votes on specific motions at GSA Council by emailing their votes to the GSA Council Chair and the Vice-President (Health Sciences) no less than one hour before the start of the relevant meeting of the GSA Council.
 - a) The Chair shall distribute the motions coming forward at the next meeting of GSA Council no less than seven days prior to the Council meeting.

- b) In order to submit a proxy vote by email, HSGSA departmental representatives shall provide their names, departments, email addresses and authorizing signatures to the Fort Garry Office of the Graduate Students' Association.
- c) In the event that a proxy vote has been cast by an HSGSA departmental representative on a specific motion and that motion is amended at Council, the proxy vote on the amended motion may be cast by the Vice-President (Health Sciences) or designate.
- 6. The GSA Internal Development & Review Committee shall be able to request, directly from the HSGSA, any publicly available documents or open minutes from any council, committee or general meeting of the HSGSA that it deems relevant for the evaluation of the performance of the Vice-President (Health Sciences).
 - a) The GSA Internal Development & Review Committee shall include a seat to be filled by an HSGSA Councilor or designate who is not a member of the HSGSA Executive Committee, as chosen by HSGSA Council.
 - b) The HSGSA Internal Development & Review Committee shall include a seat to be filled by a GSA Councilor or designate who is not a member of the GSA Executive Committee, as chosen by GSA Council.
- 7. The first instance of concerns of individual departments of the HSGSA regarding the operation of the HSGSA shall be referred back to the HSGSA for examination. The GSA reserves the right to examine any serious concerns raised by HSGSA members as to the utilization and disbursement of funds allocated to the HSGSA.
- 8. Any amendment to the Health Sciences Bylaw shall either be made by ratification by both GSA and HSGSA Councils or by ratification at a General Meeting of the GSA.
