11. New Business

11.1. Funding for U-Pass Subsidy from Conference Grant Budget Line: This year we have saved \$69 705.00 from the start of Covid-19 until August from not distributing conference grants. During this time, we have only spent \$750.00 from the conference grant budget. Considering this, and the cancellation of the U-Pass for the Fall term it was discussed that we should spend a portion of this money to subsidize the purchase of bus passes by graduate students. At \$78.00 per subsidy – the difference between the U-Pass and a four-month post-secondary transit pass – for 500 students we propose that we move \$39 000.00 from the conference grant budget to this subsidy. If we proceed,

FGS has committed to matching our contribution, which would allow us to subsidize bus passes for up to 1000 graduate students.

MOTION: BIRT the UMGSA Council approves the use of \$39 000.00 from the conference grant budget line for the subsidizing of bus passes for up to 500 graduate students.
