11.1. Revising the section on Standing Committees in the Governance and Operations Manual: Refining the terms of reference for internal committees will prevent ambiguity in the mandates of internal committees. The goal is to pay close attention to the Membership section of each standing committee.

11.3. Collective Bargaining Agreement UMFA: UMFA recently release a FAQ http://www.umfa.ca/images/pdfs/UMFA_STRIKE_VOTE_FAQ_STUDENTS_2020_FINA_L.pdf which put out a call for students to ask UMGSA to support UMFA in the event that they strike.

There was a long discussion on how to inform students about the potential UMFA strike action and what stance to take. UMSU requested that we sign on a letter with them which stayed notably neutral but urged the university and UMFA to continue to bargain. It was noted by some members that the UMSU letter was not supportive enough of UMFA.

We decided to write our own letter, and that the UMGSA President, Senator 2 and VPA would spearhead this task. The draft letter would then be sent out to the UMGSA Councillors between 12 and 5pm the next day to give them an opportunity to propose edits. We concluded that the letter should note that the UMGSA Council supports binding arbitration between the University Administration and UMFA. The following motion was proposed:

MOTION: BIRT the UMGSA writes and sends out an informative letter independently of UMSU to graduate students on October 29th, 2020 which states that the UMGSA is aware of the communications between UMFA and University Administration (link to UMFA FAQ) regarding the collective bargaining, and which formally supports bargaining in good faith, and in particular, arbitration.
