HSGSA Executive Committee and Council

In May, the HSGSA's new executive team took office. Transition period for all team members was smooth and each member had started working towards their respective roles. In consultation with previous execs, HSGSA budget for 2023-24 was presented to council and was approved in May Council meeting. HSGSA new signing authorities (President, VP Internal, and VP Marketing and Events) are now set up with BMO and Assiniboine Credit Union.

In June, the Annual Manitoba Student Health Research Forum (MSHRF) was organised in collaboration with the Rady Faculty of Health Sciences. HSGSA was in charge of registration/information booths, networking sessions, reception events and the student social evening. The student social evening for ~30 students was hosted at Tavern United downtown and students had the opportunity to network with fellow students from different universities across Manitoba. This event was well received and students had many opportunities to network. All of this was possible because of over 15 volunteers and execs' teamwork. HSGSA also gave out 3 Graduate Student Excellence Awards (\$1000 each) and 6 Graduate Student Merit Awards (\$500 each) as well as 9 poster awards for \$200 each. Two Forough Khadem Memorial Awards for 1000\$ each (one masters and one PhD) during the MSHRF awards ceremony. The HSGSA Ed-Kroger Mentorship Award 2023 was presented to Dr. Sherif Eltonsy, at the MSHRF awards ceremony.

In July, the executive committee worked on planning for Bannatyne's Fall orientation in September and a summer event on August 19th at Birds Hill Park.
