12.2 Report around risk assessment

- i. Chris has received inquiries regarding how we as an association assess risk, take stances, make statements, etc. Chris asked the council members if they'd like to receive a report on the topic to provide clarity and a reference point for if students ask you why UMGSA operates in a certain way.
- ii. It was agreed that a report on the process be prepared and circulated at a later date.
- iii. Brenda (*Applied Health Sciences*) asked that Chris briefly summarize how we assess risk at the UMGSA. Chris explained that as an executive committee and as a council we have a legal obligation to act in the best interest of the organization first, and membership second. This means before making decisions we need to ask ourselves if by doing so, are we putting the organization at risk of insolvency, legal action, are we putting our council members or staff at risk because we're doing something that could jeopardize the standing longevity of the organization? Could this decision have an impact on our relationships with the community and close partners within the university? These are the kinds of things that the President and executive members think about when considering major decisions.
- iv. Chris welcomes council members to reach out to him and schedule time to discuss this topic or any item of interest.
